

Portfolio

The Verso IM 50% Equity Income portfolio aims to generate a natural income through dividend and interest payments as well as growth through capital appreciation, all within a risk-targeted framework. It applies a fixed core asset allocation via low cost index funds.

The portfolio will normally invest 50% in income producing growth assets (equities & property), however, this can be increased and decreased by 5% if seen to be favourable to do so. The remaining assets will be invested in defensive assets (bonds & money markets).

The portfolio is managed on a discretionary basis by Verso Investment Management LLP. This means that Verso investment managers will be able to modify the underlying investments and weightings within the portfolio so that it continues to meet its objectives.

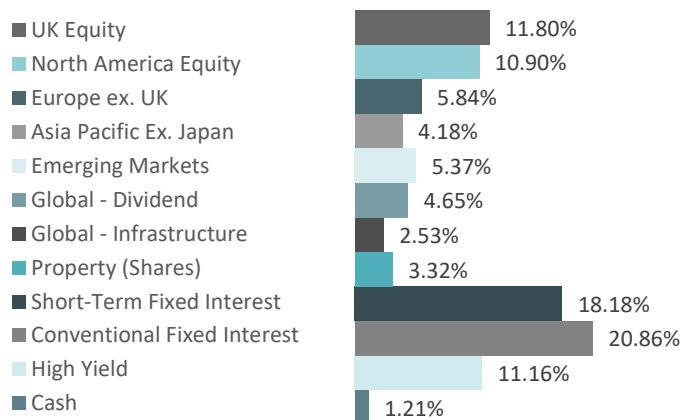
